### 6. Accidental Release Measures

#### Personal Precautions

Wear appropriate personal protection equipment for Fastener use.

#### Clean-Up Methods

Solid material does not pose a spill hazard. Avoid processes that result in the creating of dust. In the event of dust creation, avoid dry sweeping. Use water spraying/flushing or ventilated or HEPA filtered vacuum cleaning system. If not possible, gently moisten dust before collection with shovel or broom. Dispose of in closed containers.
